## Introduction

This Privacy Statement (the "Statement" or "Privacy Statement") applies to personal information that RSCC Wire and Cable., together with subsidiaries and affiliates (collectively, "r-scc," "us," "we," or "our") collects. This includes information collected via our website (<a href="https://www.r-scc.com/">https://www.r-scc.com/</a> referred to herein as "Website").

This Statement applies to information we collect on/via the Website, whether you use the Website via a computer, mobile device, or any other platform or equipment.

It does <u>not</u> apply to information collected by us offline or through any other means, including on any other website by r-scc or any third party (including our affiliates and subsidiaries); or any third party, including through any application or content (including advertisement) that may link to or be accessible from or on the Website.

## A. INFORMATION WE COLLECT AND HOW WE COLLECT IT

When you visit our Website we may collect personal information such as:

- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of r-scc's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by r-r-scc about our Website users is among the assets transferred. This Privacy Statement will apply to your personal information transferred to the new entity.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- With your consent.
- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of r-scc, our customers, or others.
